## ORDER

Intake) vide order No./NRC/NCTE/F-73/UP-2189/2007/35738 dated 05.01.2008 with an annual intake of 100 seats (Existing 100 + Additional 100 = 200 seats).

AND, WHEREAS, the institution was issued revised recognition order No F. No./NRC/NCTE/UP-2189/2015/101575 dated 21.05.2015 with an annual intake of 200 students (four units of 50 students each) from the academic session 2015-2016.

AND, WHEREAS, the institution submitted representation, received in NRC Office on 28.11.2017 with a request to reduce the seats of B.Ed. course from 200 seats (four units of 50 students each) to 100 seats (two unit of 50 students each).

AND, WHEREAS, the matter was considered by NRC in its 277th Meeting held on 05th to 06th December, 2017 and the Committee decided that the request dated 04.11.2017 of the institution for withdrawal of two units (100 seats) from four units (200 seats) in B.Ed. course granted to the institution is accepted.

NOW, THEREFORE, the Northern Regional Committee hereby reduces the number of seats of B.Ed. course from 200 seats (four units of 50 students each) to 100 seats (two unit of 50 students each) of Gandhi Institute of Professional & Technical Studies, Nangla Sher Khan Urf Jainpur (Hapur Bye Pass), Meerut – 250002 Uttar Pradesh.
